HSBC Advance customers can make withdrawal, deposit cash and balance inquiry in TRY or pay credit card debt and limit inquiry with HSBC Advance Debit or Credit Cards, credit card debt payment transactions with HSBC Advance Credit Cards via all domestic ATMs without any fee. HSBC daily transaction limits will apply to all your transactions. You may perform transactions by accessing your TRY main account linked to your Debit Card from other bank ATMs. In order to perform your demand deposit account transactions with your Credit Card, you must have an open / valid Debit Card and in order to perform your Debit Card and Credit Card transactions, you must have an open / valid Credit Card. 4. For your withdrawals from abroad HSBC ATMs and all other banks' ATMs with the HSBC Advance Debit Card, a withdrawal fee determined by HSBC Bank A.Ş. will be charged. With the HSBC Advance Debit Card, the ATM bank can offer the DCC (Dynamic Currency Conversion) service option for complete transaction with EUR-USD, GBP-USD, CAD-USD, AUD-USD parities when withdrawals from ATMs in abroad. If the DCC option is accepted by you, a difference between the amount you have withdrawn from that ATM and the amount reflected on your account may occur. You shall read such warning/ information texts on ATMs for the transactions you will make from ATMs abroad and continue the process according to your preference.
